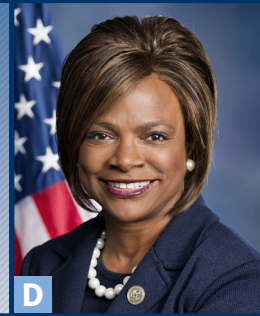

ISSUE	Val DEMINGS	Marco RUBIO
OVERTURNING ROE V. WADE: The <i>Dobbs v. Jackson Women's Health Organization</i> Supreme Court decision which overturned <i>Roe v. Wade</i> and allowed state legislators and Congress to make laws regarding abortion.	O OPPOSE ¹	S SUPPORT ¹⁰
BORN-ALIVE ABORTION SURVIVOR PROTECTIONS: The <i>Born-Alive Abortion Survivors Protection Act</i> , which would provide lifesaving medical care for babies who survive a failed abortion attempt.	O OPPOSE ²	S SUPPORT ¹¹
TAXPAYER-FUNDED ABORTIONS: Taxpayer dollars being used to fund abortions and abortion providers like Planned Parenthood.	S SUPPORT ³	O OPPOSE ¹²
RELIGIOUS LIBERTY: Protecting business owners' ability to run their businesses in accordance with biblical teaching about marriage, family, and sexuality.	O OPPOSE ⁴	S SUPPORT ¹³
REDEFINE MARRIAGE: The "Respect for Marriage Act," which repeals the Defense of Marriage Act, requires the federal government to recognize polygamy if a state legalizes it, and requires each state to recognize child marriage, incest, or open marriage if a state legalizes them. MALE PARTICIPATION IN FEMALE SPORTS: Allowing students who are biological males and who identify as women to participate in women's sports.	S SUPPORT ⁶	O OPPOSE ¹⁵
TEACHING CHILDREN SEXUAL TOPICS: Allowing controversial sexual topics to be taught to public school students as early as kindergarten.	S SUPPORT ⁷	O OPPOSE ¹⁶
FREEDOM OF SPEECH: Holding social media platforms (such as Facebook, Twitter, etc.) that oversee the virtual public square accountable for censoring viewpoints with which they disagree.	U UNKNOWN	S SUPPORT ¹⁷
NATIONALIZING ELECTIONS: Legislation that would remove voter ID requirements, implement no-excuse absentee voting, and loosen other voting requirements nationwide.	S SUPPORT ⁸	O OPPOSE ¹⁸
CHANGE SIZE OF U.S. SUPREME COURT: Adding additional seats to the U.S. Supreme Court.	S SUPPORT ⁹	O OPPOSE ¹⁹
