OVERTURNING ROE V. WADE: The <i>Dobbs v. Jackson Women's Health Organization</i> Supreme Court decision which overturned <i>Roe v. Wade</i> and allowed state legislators and Congress to make laws regarding abortion.	S SUPPORT ¹	O OPPOSE ¹⁴
BORN-ALIVE ABORTION SURVIVOR PROTECTIONS: The <i>Born-Alive Abortion Survivors Protection Act</i> , which would provide lifesaving medical care for babies who survive a failed abortion attempt.	S SUPPORT ²	U UNKNOWN
TAXPAYER-FUNDED ABORTIONS: Taxpayer dollars being used to fund abortions and abortion providers like Planned Parenthood.	O OPPOSE ³	U UNKNOWN
RELIGIOUS LIBERTY: Protecting business owners' ability to run their businesses in accordance with biblical teaching about marriage, family, and sexuality.	S SUPPORT ⁴	U UNCLEAR ¹⁵
REDEFINE MARRIAGE: The "Respect for Marriage Act," which repeals the Defense of Marriage Act, requires the federal government to recognize polygamy if a state legalizes it, and requires each state to recognize child marriage, incest, or open marriage if a state legalizes them. MALE PARTICIPATION IN FEMALE SPORTS: Allowing students who are biological males and who identify as women to participate in women's sports.	O OPPOSE ⁶	O OPPOSE ¹⁷
GENDER TRANSITION FOR MINORS: Giving minors access to puberty blockers, cross-sex hormones, and gender-reassignment surgery.	O OPPOSE ⁷	O OPPOSE ¹⁸
FREEDOM OF SPEECH: Holding social media platforms (such as Facebook, Twitter, etc.) that oversee the virtual public square accountable for censoring viewpoints with which they disagree.	S SUPPORT ⁸	U UNKNOWN
NATIONALIZING ELECTIONS: Legislation that would remove voter ID requirements, implement no-excuse absentee voting, and loosen other voting requirements nationwide.	O OPPOSE ⁹	U UNKNOWN
